The cut off date will be December 20th. If you are able, please donate to help up cigarette butts. the homeless pets.

The traffic pattern will be changing soon. The resort will install the 'do not enter' signs near County Line road and everyone will be asked to use the golf course entrance. This is done to make it easier for the shuttle and snow-plows to get through. Please be courteous when parking. Do not block the bridges, sidewalks, dumpsters, or anyone else into their space. There is parking available behind the pool along the golf course. Do not block office doors, garage, or storage units.

Homeowners please INSTRUCT your tenants to be considerate of the parking pattern and not block anyone. Renters may not be familiar with the parking situation and it is the homeowners who are also responsible to ensure they get the information out.

Keep hallways clear of clutter, including skis, trash, firewood, boots, etc.

Special points of interest:

The hallways are swept and scrubbed every 10-12 days during the winter.

Do not put hot ashes in the dumpsters or mulch areas. This includes cigarette butts.

Do not use hallways for waxing or servicing your skis.

If you have an electronic lock, regularly check and change your batteries. They tend to 'die' faster in the cold weather.

Maintenance Minute

Tis the season for water issues. Please be very mindful in keeping your cabinet doors under the sinks open and shutting your water off and draining the lines before you leave for the week. Please ask your renters and housekeepers to

do this as well. Any prevention to avoid frozen pipes will go a long way. Also maintain the temperature in your townhouse or condo. Do not turn your furnace too low or off. If you are experiencing an issue

PREVENTING FROZEN PIPES

Open kitchen and bathroom cabinet doors to allow warmer air to circulate around the plumbing. Be sure to move any harmful cleaners and household chemicals up out of the reach of children.

When the weather is very cold outside, let the cold water drip from the faucet served by exposed pipes.
Running water through



the pipe - even at a trickle - helps prevent pipes from freezing.

Keep the thermostat set to the same temperature both during the day and at night. By temporarily suspending the use of lower nighttime temperatures, you may incur a higher heating bill, but you can prevent a much more costly repair job if pipes freeze and burst.

Keep garage doors closed if there are water supply lines in the garage.
