Make sure that your chimney flue is OPEN prior to starting any fire. DO NOT

stack firewood in the hall-ways.

It is officially frozen pipe season. Turn off your water when you leave, open sink cabinet doors, and furnace at a reasonable temperature.

WATER TESTING

Please Remember to flush out your water spigots whenever the water has been shut off for any reason. This involves either the water company doing repairs or the Homeowner is gone for an extended period of time. This will ensure any settled debris is removed. Also, check your water filters (some have those small filters/screens under the spigot) since they may need cleaned or replaced as well.

WATER CONCERNS OVER LEAD

There was an issue with lead being found in the water at the Shooting Clays area. This has not affected our water at the Mountain Villas as we get our water from a different aquifer. Our water is tested twice a year by Seven Springs Municipal Authority. Samples have recently been taken from Buildings 1 and 8.

BALCONY PAINTING

Painting on the front of the balconies were done first. I will send out a reminder when they resume the painting on the inside of the balconies.

REMINDER ON OUR DECLARATION AND RULES AND REGULATIONS

Your condo door faces the common area and is subject to the MVA Rules and Regulations. Please ensure you check prior to making any "exterior" cosmetic changes to your unit. Doors are to all be the same color Elemental Tan. I have plenty of that paint at the office and can provide some to you if needed. You simply need to bring a jar, can or container for the paint. Changing the color is subject to a Tier 2 violation fine.
